5. Any of publication if it is rejected by the BSC should be taken back within 15 days by the tenderer at their own risk and cost after which no responsibility will be accepted by BSC.
6. Quantity of items may increase or decrease or may be cancelled up to any extent.
7. Tenderer is required to submit duly signed and stamped copy of terms & conditions of this bid document.
8. Latest editions of books must be supplied.
9. By default, paperback editions of books must be supplied.
10. By default, Indian editions of books must be supplied.
11. In case of unavailability of paperback and Indian editions, supply of the available editions in lieu of the default is accepted.

If the Institute has placed an order for foreign titled book but the Indian or low price edition of the same book is available in the market, the renderer will inform about the availability to library regarding this before supplying the books.
